

**NOTICE FOR ASSIGNMENT
OF ACCOMMODATION PLACES**

at JHS Student Housing residences

D.M. MUR 481/2024, L. 338/2000 and Regulation

Academic Year 2026/2027

The Management of JHS Student Housing hereby informs that, pursuant to the legislation in force on university residences, Law no. 338/2000, the Decree of the Minister of University and Research no. 481 of 26 February 2024, the rules applicable to the National Recovery and Resilience Plan (PNRR), Investment 1.7 “Student Housing”, as well as the JHS Student Housing Regulations, the procedure for the allocation of accommodation places at the university residences managed by JHS S.r.l. for the 2026/2027 academic year has been opened.

The accommodation places are reserved for non-resident university students enrolled, or intending to enrol, in degree programmes at Università Politecnica delle Marche and Università degli Studi di Macerata, for the period from **7 September 2026 to 15 July 2027**.

The residences covered by this notice are the following:

ANCONA - Università Politecnica delle Marche

- JHS **Libertas**, in Piazzale della Libertà n. 2 e n. 4;
- JHS **25 Aprile**, in Ancona, Via XXV Aprile nn. 13-17-21-23-25-27;
- JHS **Gallery**, in Ancona, Piazzale della Libertà n. 1 e n. 1/a e Via XXV Aprile n. 29/b;
- JHS **Domus**, sita in Ancona, Via XXV Aprile n. 31.

MACERATA - Università degli Studi di Macerata

- JHS **Home**, in Macerata, con ingressi in Via Gino Valentini n. 34.

Accommodation places may be allocated in single rooms or double rooms, depending on the actual availability of each residence and the organisational requirements of the manager.

The reduced average rates shall be determined and applied in accordance with the legislation in force, as well as with the acts and measures applicable to university residences developed and/or managed within the framework of the rules referred to above.

Applications for allocation of an accommodation place, duly completed and including all required elements, must be submitted by e-mail to **jhs.studenthousing@gmail.com**, by **June 15, 2026**.

If the number of applications exceeds the number of accommodation places available, allocation shall take place through a **merit ranking list**, according to the criteria and procedures established by the JHS Student Housing Regulations and on the basis of the data and documentation indicated in the official application form and in the attached documentation.

This notice concerns only the accommodation places allocated directly by JHS S.r.l. and does not concern the places reserved to the DSU body within the procedures for the right to university education.

Submission of the application entails full acceptance of the JHS Student Housing Regulations and the commitment to sign the relevant contract in the event of allocation.
